2. Bidding will be conducted through an open competitive bidding procedures using non-discretionary pass/fail" criterion as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

It is also downloadable free of charge from the websites of the Philippines Government Procurement System (PhilGEPS) and STII. Bidders who will participate in the bidding shall pay the non-refundable fee for Bidding Documents not later than the submission of their bids.

4. Bidders may bid per lot (just specify the lot/s) or with the whole contract. Bid fees will be adjusted depending on the No. of Lots to be bid by a bidder.
