



**BAC Resolution for the Awarding of the Project,
"Printing of Philippine Journal of Science (PJS) Vol. 145 No. 4"
Resolution No. 2017-030**

WHEREAS, the SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation for Negotiated Procurement under 53.9 (Small Value Procurement) of R.A. 9184 for the project, "**Printing of Philippine Journal of Science (PJS) Vol. 145 No. 4**" at the G-EPS website for three (3) days;

WHEREAS, in response to the said advertisement, five (5) bidders submitted their quotations;

WHEREAS, the TWG for Printing Services evaluated all submitted quotations and the results are as follows:

WHEREAS, the STII-BAC found the quotation of **Tangerine Print Shop** the lowest bid as read;

WHEREAS, during the evaluation of the TWG for Printing, the TWG observed that **Tangerine Print Shop** was not reachable after several times that they are being contacted for further information. Also, when one of the mobile numbers listed on their on their business card was finally contacted, it turned out that the listed number was not related to **Tangerine Print Shop**. Likewise, the office address they have given cannot be located when the TWG conducted ocular visit last 26 May 2017;

WHEREAS, the TWG for Printing Services evaluated the 2nd lowest bidder, **King Phil Printing Services** and found out that it has no Computer-to-Printer (CTP) machine which is required for a supplier to ensure good quality result at the fastest time delivery;

WHEREAS, the TWG for Printing Services evaluated the 3rd lowest bidder, **LJB Printing Services**. This printing press has provided several services for STII that includes the PJS publication with satisfactory experience;

WHEREAS, the TWG for Printing Services finds the bid proposal of **LJB Printing Services** as the most responsive bid to the needs of the end-user and hereby recommends for the awarding of contract to the said bidder;

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED to request the BAC Secretariat to prepare the Notice of Award (NOA) and Notice to Proceed (NTP) to **LJB Printing Services**.
