



**BAC Resolution for the Awarding of the Project,  
“Printing of S&T Post – 2<sup>nd</sup> Quarter 2017 Issue”  
Resolution No. 2017-045**

WHEREAS, the SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation for Negotiated Procurement under 53.9 (Small Value Procurement) of R.A. 9184 for the project, “**Printing of S&T Post – 2<sup>nd</sup> Quarter 2017 Issue**” at the G-EPS website for three (3) days;

WHEREAS, in response to the said advertisement, three (3) bidders submitted bid proposals;

WHEREAS, the STII-BAC found the bid of **PRP Printing Press** the lowest bid as read;

WHEREAS, the TWG for Printing Services evaluated the submitted bid proposals and observed that **PRP Printing Press** has no CTP thus, it outsources the CTP work. The operations of the company is not centralized in one location but spread out to different areas in Quezon City in which the TWG foresees as possible problem in terms of maintaining the quality of output and timely delivery;

WHEREAS, the TWG for Printing Services evaluated the 2<sup>nd</sup> lowest bidder, **Erzalan Printing Press** and found out that the company is owned by the brother of the owner of **PRP Printing Press**. The TWG observed that the possible disadvantage to STII since the two companies could have submitted quotations with internal arrangement for their mutual benefit and may cause undue disadvantage in ensuring quality work and transparency;


WHEREAS, the TWG for Printing Services evaluated the 3<sup>rd</sup> lowest bidder, **Gorilla Trading Printing Services** and observed that the company has CTP machine which would guarantee quality output and full control of the project. It has good track record and extensive experience dealing with government agencies, one of which is **DOST-PHIVOLCS**, and produce quality outputs as shown from the physical inspection of their sample works;






