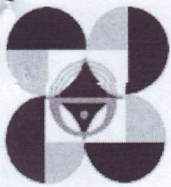
WHEREAS, the bid proposal of **American Technologies, Inc.** that were considered and complied with the Technical Specification were the following:

- To immediately post a Request for Quotation (RFQ) for the ICT Equipment items of Lots 1 and 3 after two (2) failed biddings.






