CONTRACT AGREEMENT

THIS AGREEMENT, made this 31th day of May 2017 between **SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE** with office address at DOST Complex, General Santos Avenue, Bicutan, Taguig City hereinafter called the "**Entity**" and **TENORIUM ENTERPRISE** with office address at 6 Geneva St, Provident Village, Jesus de la Peña, Marikina City hereinafter called the "**Contractor**".

WHEREAS, the Entity is desirous that the Contractor execute **Phase 3: Pre-Production, Production and Post-Production of DOSTv: Science for the People Content** hereinafter called "the Works" and the Entity has accepted the bid for **Seven Million Eight Hundred Eighty Five Thousand Pesos Only (Php 7,885,000.00)** by the Contractor for the execution and completion of such project and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - I. General and Special Conditions of Contract;
 - II. Terms of Reference
 - III. Invitation to Bid;
 - IV. Instructions to Bidders;
 - V. Bid Data Sheet;
 - VI. Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - VII. Eligibility requirements, documents and/or statements;
 - VIII. Technical Specifications (Part VII of the Bidding Documents)
 - IX. Performance Security;
 - X. Notice of Award of Contract and the Bidder's conform thereto;
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contractor in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Project, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed below:

- 15% - mobilization fund
- 50% - upon completion of production shoots from various provinces, towns, municipalities and attached agencies of DOST; initial finalized materials per topic are to be submitted, SPECIFICALLY:
 - 15 Documentary Films
 - 30 1-2minuter Sustansyarap Segments
 - 1 DOST AVP
- 20% - upon submission of the second batch of the finalized materials per topic, SPECIFICALLY:
 - 9 Documentary Films
 - 10 1-2minuter Sustansyarap Segments
 - 1 DOST AVP
- 10% - upon submission of the third batch of the finalized materials per topic, SPECIFICALLY:
 - 6 Documentary Films
 - 10 1-2minuter Sustansyarap Segments
- 5% - upon submission of the master copy





