## INVITATION TO BID (STII-PB-2017-011)

## "SUPPLY AND FABRICATION OF OFFICE FIXTURES AND FURNITURE AT THE OFFICE OF THE DIRECTOR, STII TRAINING ROOM, AND DOSTV STUDIO"

- The SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE, through the General Appropriations Act (GAA) CY 2017 (RA 10924) intends to apply the sum of One Million Pesos Only (Php1,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for STII-INFRA-2017-002. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The STII now invites bids for Supply and Fabrication of Office Fixtures and Furniture at the Office of the Director, STII Training Room, and DOSTv Studio at Bicutan, Taguig City. Completion of the Works is required one hundred twenty (120) days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
  - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from STII and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on 25 October 2017 from the address below at the STII BAC Secretariat Property Section, 2<sup>nd</sup> FIr. STII Bldg, DOST Complex, Gen. Santos Avenue, Bicutan, Taguig City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos Only (Php 1,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The STII will hold a **Pre-bid Conference** on **03 November 2017**, **1:30PM** at **CAST Room**, STII Bldg, DOST Complex, Gen. Santos Avenue, Bicutan, Taguig City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 15 November 2017, 1:30PM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **15 November 2017, 1:30PM** at **CAST Room,** STII Bldg, DOST Complex, Gen. Santos Avenue, Bicutan, Taguig City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The STII reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
