



BAC Resolution for the Awarding of the Project, "Procurement of 2 Units Book Scanner" Through Public Competitive Bidding Under Section 10

Resolution No. <u>2020-011</u>

WHEREAS, the first bidding of this project was declared a failure (Resolution No.2019-0070) due to non-submission of bid proposals, and rebidding was approved by the Head of the Procuring Entity;

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the "Procurement of Two (2) Units Book Scanner" with an Approved Budget for the Contract (ABC) amounting to ONE MILLION THREE HUNDRED THOUSAND PESOS (Php1,300,000.00) at the DOST-STII website, the PhilGEPS and conspicuous places at DOST-STII premises from 7 January 2020 to 28 January 2020;

WHEREAS, in response to the said invitation, one (1) prospective bidder purchased the bid documents, namely MICRODATA SYSTEMS AND MANAGEMENT INC.;

WHEREAS, in a public bidding held on 28 January 2020 at 10:00 a.m. at DOST-STII CAST Room, MICRODATA SYSTEMS AND MANAGEMENT INC. submitted its bid and passed the preliminary evaluation of the bid requirements;

WHEREAS, after the bidding, the bid documents were referred to the Technical Working Group (TWG) for ICT Equipment of the BAC for evaluation of the bid and post-qualification;

WHEREAS, the result of the evaluation by the TWG for ICT Equipment is as follows:

WHEREAS, MICRODATA SYSTEMS AND MANAGEMENT INC. was declared as the Single Calculated Bidder in the amount of Php1,176,444.00, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184:

Section 34.4. If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB¹⁸, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.

WHEREAS, the calculated bid of MICRODATA SYSTEMS AND MANAGEMENT INC. in the amount of P1,176,444.00 is 9.50% below the ABC, and was found to have post-qualified with all the legal, technical and financial requirements and, therefore, considered to be the bidder with the single calculated and responsive bid:

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- a) To award the project,"Procurement of Two (2) Units Book Scanner" to MICRODATA SYSTEMS AND MANAGEMENT INC. and request the BAC Secretariat to prepare the Notice of Award (NOA) and Notice to Proceed (NTP).
- b) To recommend for approval by the HoPE/Director of the DOST-Science and Technology Information Institute the forgoing findings.
