



**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND
RESPONSIVE BID (LCRB) FOR THE PROJECT
“PRINTING OF DOST-STII PUBLICATIONS FOR FY 2022”**

Resolution No. 2022-001

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the Procurement of “Printing of DOST-STII Publications for FY 2022” with an Approved Budget for the Contract (ABC) of One Million Four Hundred Ninety Thousand Pesos (Php1,490,000.00) only in the DOST-STII website, the PhilGEPS website and conspicuous places at DOST-STII premises for seven (7) days;

WHEREAS, a Virtual Pre-Bid Conference was conducted on 13 October 2021 at DOST-STII CAST Room, wherein three (3) prospective bidders was able to attend, namely: Innovation Printshoppe Inc., Dolmar Press, Inc. and Color1 Digital, Inc.;

WHEREAS, the Bids & Awards Committee (BAC) has scheduled and conducted the submission and virtual opening of bids on 25 October 2021 at 8:00AM;

WHEREAS, during the scheduled submission and opening of bids, Innovation Printshoppe Inc. and Dolmar Press, Inc. submitted their bid. The Bids and Awards Committee (BAC) through its BAC Secretariat proceeded with the opening of the Technical and Eligibility Component of the two (2) participating bidders and the bid documents were inspected by the TWG for Printing of Official Publications and Other Related Services and BAC members and both declared compliant;

WHEREAS, the TWG and BAC members proceeded in opening the bidders' financial bid proposal. The bid price as read were the following:

Dolmar Press, Inc.	Php 1,417,000.00

WHEREAS, on 26-27 October 2021, upon instruction from the BAC, the TWG conducted the evaluation and post-qualification assessment on the submitted bid. As a result, both bidders satisfactorily “**Passed**”. However, the TWG finds the proposal of Innovation Printshoppe Inc. the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:




- a) That **INNOVATION PRINTSHOPPE INC.** be declared as the Lowest Calculated and Responsive Bid (LCRB) in consideration of its total amount of bid equal to **ONE MILLION THREE HUNDRED SIXTY-SIX THOUSAND FOUR HUNDRED PESOS (Php1,366,400.00)** inclusive of all government taxes and fees;
- b) That, a Notice of Award (NOA) be issued to **INNOVATION PRINTSHOPPE INC.**, upon the release and approval of General Appropriation Act (GAA) for FY 2022; and
- c) To recommend for approval by the HoPE/Director of the DOST-Science and Technology Information Institute (DOST-STII) the forgoing findings.
