



BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND FIRST FAILURE OF BIDDING FOR LOT 2, 3, & 4 FOR THE PROJECT "PROCUREMENT OF VARIOUS E-BOOKS AND PRINTED LIBRARY MATERIALS"

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the Procurement of "**Procurement of Various E-Books and Printed Library Materials**" with an Approved Budget for the Contract (ABC) of One Million Pesos (Php1,000,000.00) only in the DOST-STII website, the PhilGEPS website and conspicuous places at DOST-STII premises for seven (7) days;

WHEREAS, a Virtual Pre-Bid Conference was conducted on 14 October 2021 at DOST-STII CAST Room, wherein one (1) interested bidder attended the conference, namely Megatxts Phil., Inc.;

WHEREAS, the Bids & Awards Committee (BAC) has scheduled and conducted the submission and virtual bid opening on 26 October 2021 at 10:00AM;

WHEREAS, during the scheduled submission and opening of bids, only **Megatxts Phil., Inc.** submitted its bid. The BAC Secretariat proceeded with the opening of the Technical and Eligibility Component of the lone bidder and the bid documents were inspected by the TWG for Library References and BAC members and was declared compliant;

WHEREAS, Megatxts Phil., Inc. was declared eligible with financial proposal as follows:

WHEREAS, on 28 October 2021, the TWG for Library References conducted the evaluation and post-qualification assessment, as the bidder with single calculated bid for Lot 1. It was declared compliant and responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- a) To declare Megatxts Phil., Inc. as the Single Calculated and Responsive Bid (SCRB) for Lot 1 for the Supply and Delivery of 55 Titles Library E-Books with a total bid price of Four Hundred Ninety-Nine Thousand Nine Hundred Eighty-Five Pesos and 50/100 Centavos (Php499,985.50);
- b) That, a Notice of Award (NOA) be issued to Megatxts Phil., Inc. upon the release and approval of General Appropriations Act (GAA) for FY 2022.
- c) To declare First Failure of Bidding for the procurement of Lots 2, 3, and 4;
- d) To repost the requirement for Lots 2, 3, and 4 as Request for Quotation (RFQ) under Section 53.9 Negotiated Procurement-Small Value Procurement of R.A. 9184; and
- e) To recommend for approval by the HoPE/Director of the DOST-Science and Technology Information Institute (DOST-STII) the forgoing findings.
