



BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE PROJECT "SOCIAL MEDIA INTEGRATION AND SEARCH ENGINE OPTIMIZATION OF DOSTV ONLINE PLATFORMS (SOCIAL MEDIA & WEBSITE)"
