

BAC Resolution for the Awarding of the Project, "Procurement of DOST-STII Various Software Subscription for CY 2022"

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the "Procurement of DOST-STII Various Software Subscription for CY 2022" with an Approved Budget for the Contract (ABC) amounting to TWO MILLION THREE HUNDRED NINETY-SEVEN THOUSAND FORTY-TWO PESOS AND 20/100 ONLY (Php2,397,042.20) at the DOST-STII website, PhilGEPS website and conspicuous places of DOST-STII premises for seven (7) days;
