

BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE PROJECT "ONE (1) LOT PRINTING OF DOST-STII PUBLICATIONS FOR FY 2023"

Resolution No. 2023-002

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the Procurement of "One (1) Lot Printing of DOST-STII Publications for FY 2023" with an Approved Budget for the Contract (ABC) of One Million Eight Hundred Thousand Pesos Only (Php1,800,000.00) in the DOST-STII website, the PhilGEPS website and conspicuous places at DOST-STII premises for seven (7) days;

WHEREAS, a Virtual Pre-Bid Conference was conducted on 26 October 2022 at DOST-STII CAST Room, wherein four (4) prospective bidders were able to attend, namely: Innovation Printshoppe Inc., Dolmar Press, Inc., Color1 Digital, Inc., and Transprint Corporation;

WHEREAS, the Bids & Awards Committee (BAC) has scheduled the deadline of submission and virtual opening of bids on 08 November 2022 at 1:00PM. As a result, three (3) bidders purchased bidding documents and successfully submitted their bid before the deadline, namely: VJ Graphics Arts, Inc., Color1 Digital, Inc., and Gorilla Trading;

WHEREAS, during the scheduled Opening of Bids, the envelope 1 containing the eligibility and technical components of the three (3) bidders were opened. The TWG and the BAC members carefully examined all the components of envelope 1, as a result, the following has been observed:

WHEREAS, on the instruction from the BAC to proceed with the Post-Qualification of the bid submitted by Color1 Digital, Inc., the BAC-TWG convened and conducted their Post-Qualification:

WHEREAS, on 09-24 November 2022, the TWG conducted the thorough evaluation and post-qualification assessment on the submitted bid. As a result, the bid of Color1Digital, Inc. was deemed compliant with all the requirements and conditions specified in the Bidding Documents, hence making its bid for this project as the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- a) That COLOR1DIGITAL, INC. be declared as the Lowest Calculated and Responsive Bid (LCRB) in consideration of its total amount of bid equal to ONE MILLION FIVE HUNDRED NINETY-NINE THOUSAND PESOS ONLY (Php1,599,000.00) inclusive of all government taxes and fees;
- b) That, a Notice of Award (NOA) be issued to COLOR1DIGITAL, INC., upon the approval and effectivity of General Appropriations Act (GAA) for FY 2023; and
- c) To recommend for approval by the HoPE/Director of the DOST-Science and Technology Information Institute (DOST-STII) the forgoing findings.
