

BAC RESOLUTION FOR THE AWARDING OF THE PROJECT, "SOCIAL MEDIA ADVERTISING AND ONLINE MARKETING FOR DOSTV ONLINE PLATFORMS FOR FY 2023"

WHEREAS, BAC Resolution No. 2023-004 was issued on 08 December 2022 declaring post-disqualification of TripplesPH Corporation as the bidder with the Lowest Calculated Bid for the project "Social Media Advertising and Online Marketing for DOSTv Online Platforms for FY 2023";

WHEREAS, on 22 December 2022, the Bids and Awards Committee issued a Notice of Post-Disqualification to TripplesPH Corporation;

WHEREAS, on 31 December 2022, TripplesPH Corporation filed a Motion for Reconsideration but was denied by the BAC on 05 January 2023;

WHEREAS, on 06 January 2023, the BAC instructed the TWG for Scientific, Scholarly, or Artistic Work, Exclusive Technology, and Media Services to proceed with the post-qualification and evaluation of the 2nd lowest calculated bidder, namely: Carbon Digital, Inc.;

WHEREAS, the TWG conducted the thorough evaluation and post-qualification assessment on the submitted bid of Carbon Digital, Inc. As a result, the said bidder was deemed compliant with all the requirements and conditions specified in the Bidding Documents, hence making its bid for this project as the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- a) To declare CARBON DIGITAL, INC. as the Lowest Calculated and Responsive Bid (LCRB) for the project "Social Media Advertising and Online Marketing for DOSTv Online Platforms for FY 2023" in consideration of its total amount of bid equal to ONE MILLION ONE HUNDRED SEVENTY-EIGHT THOUSAND TWO HUNDRED FORTY PESOS ONLY (Php1,178,240.00) inclusive of all government taxes and fees;
- b) To request the BAC Secretariat to prepare the Notice of Award (NOA), Contract Agreement, and Notice to Proceed (NTP); and
- c) To RECOMMEND FOR APPROVAL to the HoPE/Director of the DOST-Science and Technology Information Institute the above findings.
