

BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE PROJECT "SOCIAL MEDIA ADVERTISING AND ONLINE MARKETING FOR SCIENCE PINAS"

Resolution No. 2023-040

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the Procurement of "Social Media Advertising and Online Marketing for Science Pinas" with an Approved Budget for the Contract (ABC) of Two Million Four Hundred Twenty Thousand Pesos Only (Php2,420,000.00) in the DOST-STII website, the PhilGEPS website and conspicuous places at DOST-STII premises for seven (7) days;

WHEREAS, a Virtual Pre-Bid Conference was conducted on 20 October 2023 at DOST-STII CAST Room, wherein nine (9) prospective bidders were able to attend, namely: Deus Enterprises Co., Swara Sug Media Corp., TripplesPH Corp., Carbondigital, Inc., Organic Intelligence Consulting, Inc., DRVN Business Consulting Co., Chimes Consulting, Inc., Outcomm Inc., and Marcus Phoenix Media Production Corp.;

WHEREAS, the Bids & Awards Committee (BAC) has scheduled the deadline of submission and opening of bids on 06 November 2023 at 4:00PM. As a result, five (5) bidders successfully submitted their bid before the deadline, namely: Carbondigital, Inc., Adrow Creatives Inc., TripplesPH Corporation, MyBusybee Inc., and Organic Intelligence Consulting, Inc.;

WHEREAS, during the scheduled Opening of Bids, the envelope 1 containing the eligibility and technical components of the five (5) bidders were opened. The TWG and the BAC members carefully examined all the components of envelope 1, as a result, the following has been observed:

WHEREAS, due to the findings, Adrow Creatives Inc. and Organic Intelligence Consulting, Inc. were Disqualified because of failure to comply with the eligibility and technical requirements of this project and opening of their Financial Documents were halted;

WHEREAS, the financial component envelope of the eligible bidders who have passed the preliminary examination of the technical and eligibility requirements were opened and, consequently, the BAC read and recorded their financial bids as follows:

WHEREAS, a Request for Reconsideration from Organic Intelligence Consulting, Inc. was received on 09 November 2023 and was then denied on 14 November 2023 (see attached notice);

WHEREAS, upon evaluation and validation of the bids submitted, the BAC declared TripplesPH Corporation as the Lowest Bid As Read in the amount of Php1,805,280.00;

WHEREAS, on the instruction from the BAC to proceed with the post-qualification of the bid submitted by TripplesPH Corporation, the BAC-TWG convened and conducted their post-qualification;

WHEREAS, on 21 November 2023, the TWG conducted the thorough evaluation and post-qualification assessment on the submitted bid. As a result, the bid of TripplesPH Corporation was deemed compliant with all the requirements and conditions specified in the Bidding Documents, hence making its bid for this project as the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, We the members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- a) To recommend the award of contract to TRIPPLESPH CORPORATION as the Lowest Calculated and Responsive Bid (LCRB) with a total contract price of ONE MILLION EIGHT HUNDRED FIVE THOUSAND TWO HUNDRED EIGHTY PESOS ONLY (Php1,805,280.00) inclusive of all government taxes and fees; and
- b) To recommend for approval by the HoPE/Director of the DOST-Science and Technology Information Institute (DOST-STII) the forgoing findings.
