



BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE PROJECT "DESIGN AND BUILD -CONVERSION OF ATRIUM TO LIBRARY MAKERSPACE, BASEMENT FOR OFFICE SPACE AND SECOND FLOOR FOR FAD EXTENSION OFFICE"

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the project "Design and Build - Conversion of Atrium to Library Makerspace, Basement for Office Space and Second Floor for FAD Extension Office" with an Approved Budget for the Contract (ABC) of Six Million Eight Hundred Twenty-Eight Thousand Pesos Only (Php6,828,000.00) in the DOST-STII website, the PhilGEPS website and conspicuous places at DOST-STII premises for seven (7) days:

WHEREAS, a Virtual Pre-Bid Conference was conducted on 15 December 2023 at DOST-STII Mini Theater, wherein one (1) prospective bidder attended the conference. namely: VASTCON ASIA CONSTRUCTION INC.;

WHEREAS, the Bids & Awards Committee (BAC) has scheduled the deadline for submission of bids and virtual bid opening on 27 December 2023 at 9:00 AM. As a result, only one (1) bidder purchased bidding documents and successfully submitted its bid before the deadline, specifically: Vastcon Asia Construction Inc.:

WHEREAS, during the scheduled Opening of Bids, the envelope 1 containing the eligibility and technical components of Vastcon Asia Construction Inc. was opened. The TWG for Infrastructure Projects and BAC Members carefully examined the said components, as a result, Vastcon Asia Construction Inc. has successfully submitted the complete and accurate documents required by 2016 IRR of RA 9184. Hence, the financial envelope of the said bidder was opened;

WHEREAS, the TWG and BAC members proceeded in examination of the bidder's financial bid proposal. The bid price was Six Million Eight Hundred Two Thousand Four Hundred Eighty One Pesos And 77/100 Only (Php6,802,481.77) which is within the ABC and was therefore declared compliant:

WHEREAS, on the instruction from the BAC, the TWG conducted the thorough evaluation and post-qualification assessment on the submitted bid. As a result, the bid of Vastcon Asia Construction Inc. was deemed compliant with all the requirements and conditions specified in the Bidding Documents, hence making its bid for this project as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:









- a) To declare VASTCON ASIA CONSTRUCTION INC., as the Bidder with a Single Calculated Responsive Bid (LCRB) for the abovementioned project;
- b) To recommend the award of contract to VASTCON ASIA CONSTRUCTION INC. in the amount of SIX MILLION EIGHT HUNDRED TWO THOUSAND FOUR HUNDRED EIGHTY ONE PESOS AND 77/100 ONLY (Php6,802,481.77), inclusive of all government taxes and fees; and
- c) To recommend for approval by the HoPE/Director of the DOST-Science and Technology Information Institute (DOST-STII) the forgoing findings.
