- 2. Works performed hereon are subject to inspection and acceptance by the SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE and/or State Auditor their authorized representatives.
- 3. Upon contractor's failure to perform and or finish the work, when due, the SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE shall impose the following penalties: (1) to deduct for each day of delay, after the period stipulated. A liquidated damage in the amount of 1/10 of 1% per day if the total value of the contract, or if the contract has been partially performed within the stipulated time the total value of the unperformed portion thereof.
